Fair Chase is the ethical, sportsmanlike, and lawful pursuit and taking of any free-ranging wild game animal in a manner that does not give the hunter an improper or unfair advantage over the game animals. It reflects an ideal to pursue game in the field in a manner that pays respect to the animals hunted and the traditions of hunting as a mechanism for conservation. Fair chase is an approach that elevates the quality of the chase, the challenge, and experience above all else. By not overwhelming game species with human capabilities, fair chase helps define a hunter's engagement in conservation.
